## Board of Director's Meeting: January 14, 2015

**Audit for Fiscal Year 2013-14:** Karina Lapp and Sarah Beer of the accounting firm Hathaway, Ksenzulak and Lapp, presented their review of the District's Financial Statements for Fiscal Year Ending June 30, 2014. The Independent Auditor's Report contains the opinions of the accounting firm regarding their review of the District's financial position as of June 30, 2014 and the results of its operations and changes in net assets and cash flow for the year. The review was conducted in conformity with the accounting principles and systems prescribed by the State Controller's Office and State regulations governing Special Districts.

### **Transfer of Property Tax Revenue and Annual Tax Increment to Shasta Community Services District Resulting from Foxwood Unit #2 Reorganization:**


The Board of Directors received an application to de-annex a portion of Foxwood Unit 2 located along Lower Springs Road to be annexed into the Shasta Community Services District. Pursuant to Revenue and Taxation Code Section 99(a)(1) the amount of annual tax increment to be exchanged is to be determined by negotiation. District Manager Muehlbacher negotiated with the District Manager of Shasta CSD to divide the taxes based upon the percentage of acreage going to each District. The Board unanimously adopted Resolution 2015-1 authorizing transfer of property tax revenue and annual tax increment to the Shasta Community services District as determined by negotiations reflected in LAFCO File NO. 2014-01.

# Drought Watch

**Where did the rain go?** With the dry conditions and warmer temperatures, it does not feel like January. This time of year we are usually bundled up and holding a warm drink in our hand; however, this is turning out to be one of the warmest Januaries in recent history.

In consideration of the persistent drought conditions, please continue to conserve 15% of your usage last year. Also, if you begin watering outdoors, please remember to adhere to the following outdoor watering schedule:

- Outdoor watering hours are from 12:00 am to 9:00 am and 6:00 pm to 12:00 am.
- Addresses ending with an **odd** number may water only on Wednesday, Friday and Sunday.
- Addresses ending with an **even** number may water only on Tuesday, Thursday and Saturday.
- **No watering is allowed on Mondays.**

If we work together we can hopefully avoid mandatory restrictions and costly penalties.

We believe in keeping our customers well informed regarding the drought and water storage conditions. Please refer to our website for additional drought information and conservation tips.

***Below is a portion of the recent news release dated January 23, 2015 from the Bureau of Reclamation including the latest storage levels:***

"While we were encouraged by storms in December, this very dry January illustrates just how precarious our water supplies can become," said Mid-Pacific Regional Director David Murillo. "Since 2015 may be another critically dry water year, we are being extremely cautious as we develop initial operation plans and allocations for CVP water contractors. By building on what we learned last year, I am confident that we can maximize operational flexibility for the benefit of all water users."

## Grant School Kindergarten Round-Up

If you have or know of a child that lives in the Grant School District who will be attending kindergarten next year, now is the time to come by the office and sign up for kindergarten. The Kindergarten Round-Up is scheduled for Tuesday, March 17th beginning with a tour at 8:45 am and a parent information meeting to follow in the cafeteria. Kindergarten registration packets will be mailed in mid February. Children must be 5 years old by September 1, 2015 in order to register for the 2015-2016 school year. Parents of children turning 5 between September 2nd and December 2nd, 2015 should call the office for enrollment options. Please be sure to bring the following if not previously turned in:

- Proof of Residence
- Birth Certificate
- Immunization Record
- Social Security Number
