## Tank Maintenance Program - Tank C1 Washout

The Tank Maintenance Program has been underway for the past several months. In order to inspect, clean and repair the tanks they must first be emptied of water. It is important to note that water is not wasted during this process. The water is moved from one tank to another in order to continue to meet the demands of the District.

This month the washout of Tank C1 has been completed. This 1-Million gallon tank is the largest in our inventory. While examining the tank, it showed some metal loss in the tank floor which was repaired during the washout. They also discovered that the overflow drainage needed repair. This repair was completed by our operator staff.

The B Tank is scheduled to be completely recoated and improved next year.

## Register for Code Red

SHASCOM 9-1-1, the county-wide 9-1-1 center uses CODE RED, an emergency citizen notification system for cell phones. To register your cell phone, go to the SHASCOM 9-1-1 website, [www.shascom911.com](http://www.shascom911.com), and choose "Citizen Notification" near the top of the page. You can also access the link for SHASCOM 911 on the District's website.

While registering you can choose to either receive a text or a voice message. TDD/TTY devices (telephones for the hearing impaired) may also be registered. You do not need to register your landline phone, as this data is already in the SHASCOM 9-1-1 system. **Also, please make sure the Centerville District Office has your current phone number on file and don't forget to sign up for Emergency Alerts on our website.**



## So When Can I Water?

### OUTDOOR IRRIGATION RESTRICTIONS

Outdoor use of potable water – **All customers must reduce outdoor use of potable water by adhering to the following restrictions:**

1. Outdoor irrigation is permitted **only** between the hours of 12:00 a.m. and 9:00 a.m. and 6:00 pm to 12:00 am on the days described below:
  - a. Addresses ending with an **odd** number may water only on Wednesday, Friday and Sunday and only within the permitted time period.
  - b. Addresses ending with an **even** number may water only on Tuesday, Thursday and Saturday and only within the permitted time period.
  - c. For repair purposes only, outdoor irrigation systems can be operated between the hours of 6:00 a.m. and 9:00 p.m. for a reasonable period of time not to exceed five (5) minutes per zone cycle and only long enough to verify proper operation and make sprinkler adjustments.

Below is our District-wide projected water budget for the 2022 Water Year ending February 2023. As you can see from the table, our usage in March was considerably higher than projected. In order to stay within our 1,050 AF water supply, we must continue our conservation! This overage in March will impact what's available for the remainder of this water year.


